The table lists the contaminants that we have detected during the 2023 calendar year. As you can see by the table, our system had no violations. We are proud that your drinking water meets or exceeds all Federal and State requirements. We have learned through our monitoring and testing that some constituents have been detected. The EPA has determined that your water is SAFE at these levels. The presence of these contaminants in the water does not necessarily indicate that the water poses a health risk. Unless otherwise indicated, the data presented in this table is from the testing done between January 1 and December 31, 2023. Indiana Department of Environmental

Management (IDEM) requires us to monitor for certain contaminants at a frequency less than once per year because the concentrations of these contaminants are not expected to vary significantly from one year to another.

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of land or through the ground, it dissolves naturally occurring minerals and in some cases radioactive materials and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:

*Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.

*Inorganic contaminants such as salts and metals, which can be naturally occurring or result from urban storm runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.

*Pesticides and herbicides, which may come from a variety of sources such as agricultural, storm water runoff and residential uses.

*Organic chemicals including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production and can also come from gas stations, urban storm runoff and septic systems.

*Radioactive materials which can be naturally occurring or be the result of oil and gas production and mining activities.

MCL's are set at very stringent levels. To understand the possible health effects described for many regulated constituents, a person would have to drink 2 liters of water every day at the MCL level for a lifetime to have a 1 in a million chance of having the described health effect.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as

persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly and infants can be particularly at risk for infections. These people should seek advice about drinking water from their health care providers. Water Quality Test Results

Definitions – The following tables contain scientific terms and measures, some of which may require explanation.

Avg – regulatory compliance with some MCLs are based on running annual average of monthly samples.

Maximum Containment Level or MCL- the highest level of a containment that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment.

Level 1 Assessment – a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system.

Maximum Contaminant Level Goal (MCLG) – level of a contaminant in drinking water below which there is no known or expected risk to health,. MCLGs allow for a margin of safety.

Level 2 Assessment – a very detailed study of the water system to identify potential problems and determine (if possible) why an E. coli MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.

Maximum residual disinfectant level (MRDL) – highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

ppm - parts per million (Think of one part per million as 1 cent in \$10,000)

ppb - parts per billion (Think of one part per billion as 1 cent in \$10 million)

mg/l - milligrams per liter

pCi/L - picocuries per liter

Ug/L - micrograms per liter

MCL is the highest level of a contaminant that is allowed in drinking water.

MCLG is the level of a contaminant in drinking water below which there is no known or expected risk to health.

MRDL is the highest level of a disinfectant allowed in drinking water.

AL is the highest level of contaminant which, when exceeded, triggers treatment or other requirements which a system must follow.

Special Note on Lead: If present, elevated levels of lead can cause serious health problems, especially in pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Our system is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested.
